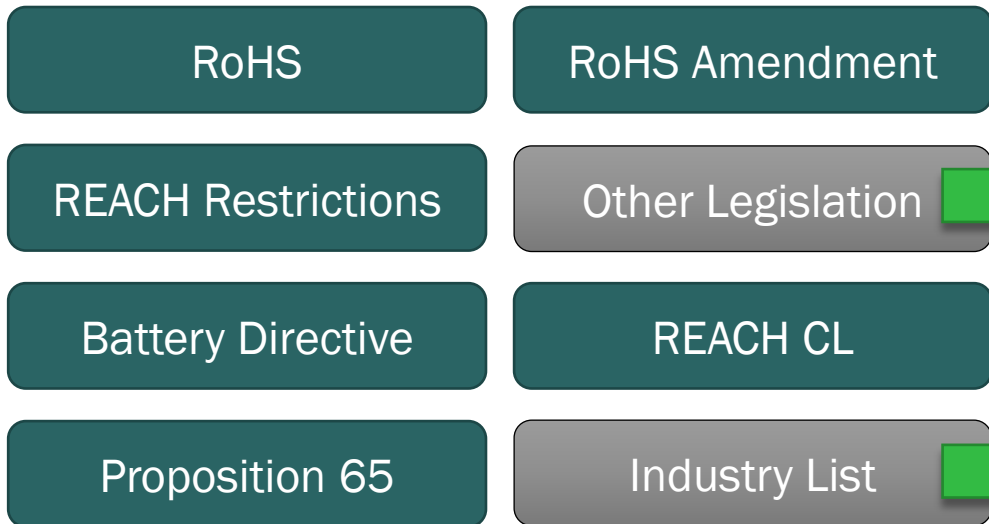

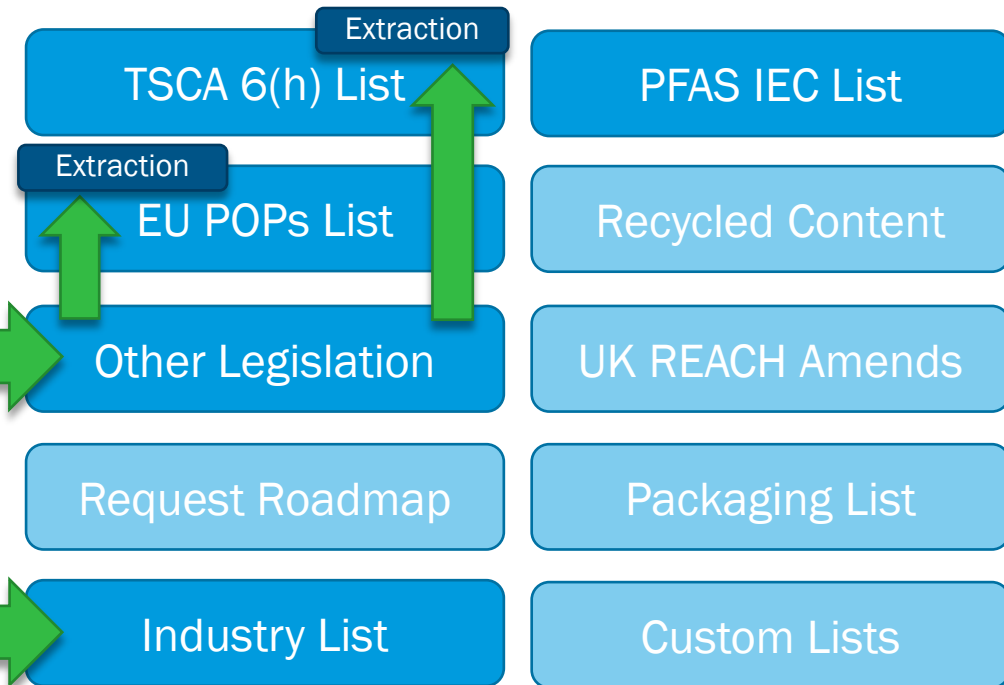
Primary Lists

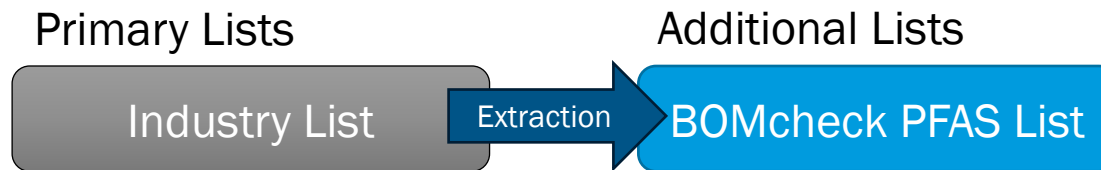

- All Primary Lists will be available to:
 - **Manufacturer Suite (Superuser) and Supplier users** for declaration, supplier requests and retrieve data tools
 - **Manufacturer Access users** for retrieve data tools
- All Additional Lists will be available to:
 - **Manufacturer Suite (Superuser) users** for declaration and request forwarding
 - **BOMcheck Professional Suite users** for declaration, supplier requests and retrieve data
 - **BOMcheck Professional Access users** for retrieve data tools
 - **Supplier users** for declaration

BOMcheck Regulatory Content

Extraction = Changes to PFAS Substance Entry

- **Target date: 10th June 2024**
- As of BOMcheck v8.0, the current PFAS Substance Category entry in the Industry Substances List will be replaced with a new PFAS entry in the new BOMcheck PFAS List.
- The BOMcheck PFAS List will be in the new Additional Lists grouping, available for declaration in RCDs for all suppliers, available in Supplier Requests, Retrieve Data and XML/other exports for BOMcheck Professional customers only.
- All existing supplier disclosure information will be migrated to this new Substance Category and improved data linking to the underlying BOMcheck PFAS reference list will be created where possible.



Only the entry for PFAS (“Per and polyfluoroalkyl substances”) will be extracted to the new BOMcheck PFAS List. All other substances will remain in the Industry List.

BOMcheck Regulatory Content

Extraction = Changes to Other Legislation & Industry List

- Target date: Jan/Feb 2025
- As of BOMcheck v8.2, Other Regulated Substances and Industry Lists will be migrated to the Additional Lists grouping.
- Extraction of TSCA and POPs from the Other Regulated Substances list will remove ~10 substances to new regulatory aligned list locations.
- BOMcheck will provide a substance mapping and guidance Q4 2024.
