BOMcheck Platform API Available & Future Functionality

There are three main features, plus supporting data which users may interact with via the Platform API:

- 1. Submit Supplier Requests: Launch Send Requests to Suppliers campaigns to collect compliance data from suppliers as per the BOMcheck <u>Supply Chain Tools</u> (via XML Upload).
- 2. Submit Compliance Declarations: Create RCDs and FMDs in the platform against the supported Declarable Substance Lists as per the BOMcheck <u>Declaration Tools</u> (via XML Upload).
- **3. Download Declarations:** Download and consume supplier compliance declarations (RCDs and FMDs) as per the BOMcheck <u>Retrieve Data Tools</u> (via XML Download).
- & **Download Integration Data:** Download a range of integration data including supported BOMcheck Substance and Exemption Lists, Lists of Suppliers, DUNs/CAS numbers etc. (via XML Download).

Challenge 3: SCIP Compliance Obligations

How do OEMs identify where SVHCs occur within their product articles, across complex supply chains and ensure this data is submitted to SCIP correctly?

- What? •
 - ECHA SCIP = Substances of Concern in Products •
 - From Jan 2021, companies in EU must report info to the SCIP database for articles/complex • objects (components/products) supplied in a MS that contain SVHC above 0.1% w/w per article
 - **SVHC** = Substance of Very High Concern listed on REACH Candidate List
- Who? •
 - <u>ALL</u> companies in the supply chain (Producer, Assembler, Distributor/reseller) •
 - Need Legal Entity in Member State (MS) to be able to register
- How?
 - Provisons are outlined in Waste Framework Directive implemented at MS level ٠
 - ECHA gives three submission-options... •






